**CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

The date of this Certificate of Amendment to the Articles of Incorporation of Sun City Center West Master Association, Inc., a Florida not-for-profit corporation, is September 14, 2015.

RECITALS

WHEREAS, the Articles of Incorporation of Sun City Center West Master Association, Inc., a Florida corporation not for profit (the "Master Association"), were originally filed with the Secretary of State of the State of Florida on May 29, 1973 and recorded in Official Records Book 2685, Page 934, public records of Hillsborough County, Florida, as amended (the "Articles"); and

WHEREAS, the Articles were subsequently amended by the filing of the Amended and Restated Articles of Incorporation of Sun City Center West Master Association, Inc., as filed with the Secretary of State of Florida on June 28, 2010 and as recorded in Official Records Book 19851, Page 1115, public records of Hillsborough County, Florida, as amended (the "Amended and Restated Articles of Incorporation"); and

WHEREAS, the Amended and Restated Articles of Incorporation provides in Article XIII, that the Articles may be amended by an affirmative vote of the members of the Corporation present and voting at such meeting, as well as an affirmative vote of a majority of the Board of Directors of the Corporation; and

Glover, as Secretary, of Sun City Center West Master Association, Inc. do hereby certify that, on September 14, 2015 the Board of Directors and the Membership of the Master Association duly approved the Amendment to Article VI of the Amended and Restated Articles of Incorporation of Sun City Center West Master Association, Inc. attached hereto and incorporated herein as Exhibit "A".

Article VI.
Board of Directors

Section 2. ~~Except as otherwise provided in these Articles of Incorporation,~~ Directors shall be elected by the voting members in accordance with the Bylaws, at the regular annual meeting of the membership of the Corporation ~~to be held between April 1 and April 15 each year on the date and at the time and location to be determined by the Board of Directors in its sole discretion.~~ Directors shall be elected to serve for a term of one (1) year. ~~In the event of a vacancy, the elected Directors may appoint an additional Director to serve the balance of said year.~~
